The Regular Meeting of the Board of Education of Millburn School District 24, Lake County, Illinois, held at Millburn West School, was called to order at 8:05 p.m. by President Robert Reding. Roll call was taken with the following Board Members in attendance: Diane Campbell, Jane Gattone, Scott Miller, Joseph Pineau, Robert Reding, Lisa Scanio and Chris Stream.

<u>PUBLIC COMMENT</u> – Valerie Powley asked the Board to gather all the facts before making a decision regarding the grade configuration of the schools.

ADDITION OF NON-ACTION ITEMS – Several additional items were discussed, including:

- House Bill 3793 -- Lisa Scanio stated that House Bill 3793 failed in the Illinois Legislature last week. She thanked Jason Lind and Robert Reding for traveling to Springfield to lobby against the bill.
- Legislative Breakfast Ms. Scanio stated that she, Mr. Lind and Mr. Reding joined other local schools at a recent breakfast meeting with state representatives from the area. Mr. Lind explained that the purpose of the meeting was to establish a relationship with the lawmakers and to discuss issues of importance to education.

- IASB, IASA, IASBO Conference Board Members who attended the recent Tri-Conference reported on the various sessions they attended. Board Members agreed to share a summary of their experiences with each other.
- Superintendent Goals Lisa Scanio commented on the Board's recent approval of the Superintendent Goals. She said that although the Board discussed attaching a student performance goal and an achievement goal to the superintendent's contract, these two items were already in the contract and no further action was warranted. Other Board Members agreed.
- Public Forums The Board discussed possible dates for hosting public forums to present information and hear public opinion regarding the grade configuration of the schools, strategic planning, financial outlook and other topics of interest. Jason Lind reminded the Board that the Facilities and Finance Committee will be updating the Board on information it has gathered regarding the grade configuration issue. This update is scheduled for the December Committee of the Whole Meeting.
- SEDOL meeting Diane Campbell reported that the next SEDOL Governing Board meeting is Nov. 30, and that SEDOL is inviting each district to bring an additional Board Member to attend. Ms. Campbell said that any Board Member who would like to attend should contact her.
