The Regular Meeting of the Board of Education of Millburn School District 24, Lake County, Illinois, held at Millburn Middle School, was called to order at 7:16 p.m. by President Joseph Pineau. <u>DISPOSITION OF SURPLUS LIBRARY BOOKS</u> – Supt. Jason Lind explained that there is a surplus of about 400 library books that includes multiple copies of the same title or books that are no longer used. He is recommending that the district sell the surplus books to the taxpayers at a cost of about 50 cents or \$1. Any items that are not sold will be donated to a worthy cause. A motion was made by Nichol Mangino and seconded by Trak Patel to approve a Resolution to Dispose of Surplus Library Books. On a roll call vote, the following Board Members voted Aye: Joseph Pineau, Jane Gattone, Nichol Mangino, Trak Patel and Diane Campbell. Nays: none. Absent: Greg Ball. The motion passed.

SALARY COMPENSATION REPORT – The Board reviewed the Salary Compensation Report of Certified Staff that is required by the state. A motion was made by Jane Gattone and seconded by Trak Patel to approve the Salary Compensation Report. On a voice vote, all Board Members voted Aye. Nays: none. Absent: Greg Ball. The motion passed.

Joseph Pineau encouraged Board Members to call the school principals and schedule a visit to one or both of the schools.

#### SUPERINTENDENT REPORT

Supt. Jason Lind said he met recently with High School Dist. 117 and its grade school feeder districts. Topics included changes in testing for incoming freshmen, and an opportunity for shared services regarding the purchase of testing materials. Supt. Lind also said he is planning to send a community letter explaining proposed state legislation that could adversely affect Millburn's financial outlook.

## **BUSINESS OFFICE REPORT**

Dr. Stephen Johns reported the following:

- The district has received about 84.5 percent of the estimated property tax revenue for calendar year 2014. This is slightly ahead of last year's receipts.
- The Regional Office of Education Annual Building Inspection found only a few items that were identified as problematic, and was much-improved from last year's report.
- The first reading of the Property Tax Levy will be presented at the October Regular Meeting.

It was noted that Dr. Stephen Johns, Joanne Rathunde, Jake Jorgenson, Bennett Walshire and Bernadette Hanna exited the meeting at 7:44 p.m.

# **EXECUTIVE SESSION**

A motion was made by Nichol Mangino and seconded by Joseph Pineau to enter into Executive Session for the purpose of the selection of a person to fill a public office, as defined in the Open Meetings Act, including a vacancy in a public office, when the public body is given power to appoint under law or ordinance, or the discipline, performance of removal of the occupant of a public office, when the public body is given power to remove the occupant under law or ordinance. On a roll call vote, the following Board Members voted Aye: Jane Gattone, Nichol Mangino, Trak Patel, Diane Campbell and Joseph Pineau. Nays: none. Absent: Greg Ball. The motion passed. The Executive Session began at 7:50 p.m.

A motion was made by Diane Campbell and seconded by Joseph Pineau to appoint Casandra Slade to fill the School Board vacancy. On a voice vote, all Board Members voted Aye. Nays: none. Absent: Greg Ball. The motion passed.

ADMINISTER OATH OF OFFICE - Casandra Slade recited the Oath of Office as required by the state.

There being no further business, a motion was made by Casandra Slade and seconded by Jane Gattone to adjourn the Regular Meeting. On a voice vote, all Board Members voted Aye. Nays: none. Absent: Greg Ball. The motion passed. The Regular Meeting adjourned at 9:10 p.m.
