<u>BUILDER DONATION DOCUMENTS</u> – Dr. Stephen Johns explained that the district needs to update the developer agreement that was approved in 2003 for the Cottonwood Estates subdivision. Since that time portions of the property have been sold and now there are three developers. A motion was made by Carissa LaTourette and seconded by Casandra Slade to approve the Builder Documents for Cottonwood Estates, as follows:

- 1. Updated School Cash Donation Agreement for Re-subdivision of Cottonwood Estates—Exhibit A
- 2. Cottonwood Estates Contribution Agreement Addendum
- 3. Indemnification Agreement with Lake County to Collect Cash Contributions on Behalf of Millburn School District
- 4. Letter to Lake County Regional Office of Education regarding the School and Park Contributions from the Re-subdivision of Cottonwood Estates.

<u>CURRICULUM</u>, <u>SCHEDULE AND STAFFING FOR SCHOOL YEAR 2016-17</u> – Supt. Jason Lind explained that the next 11 agenda items are related to proposed changes in the curriculum, schedule and staffing for next school year. He said that all of the recommendations are based on the results of the Strategic Plan. Theses topics have been discussed at several previous School Board meetings.

ADDITION OF SPANISH AS FOREIGN LANGUAGE OPTION — A motion was made by Trak Patel and seconded by Casandra Slade to approve the addition of Spanish as a foreign language option in middle school. On a roll call vote, the following Board Members voted Aye: Jane Gattone, Carissa LaTourette, Diane Campbell, Trak Patel and Casandra Slade. Nays: none. Absent: Nichol Mangino. The motion passed.

APPROVE MIDDLE SCHOOL SCHEDULE—Supt. Jason Lind said the proposed changes in the middle school schedule provide an additional period in the school day that will accommodate Specials, Special Education, AIM and other classes and options. The schedule also extends the school day by 11 minutes. A motion was made by Carissa LaTourette and seconded by Diane Campbell to approve the middle school schedule, as presented. On a roll call vote, the following Board Members voted Aye: Carissa LaTourette, Diane Campbell, Trak Patel, Casandra Slade and Jane Gattone. Nays: none. Absent: Nichol Mangino. The motion passed.

BAND AND CHOIR DURING THE SCHOOL DAY -- A motion was made by Diane Campbell and seconded by Carissa LaTourette to approve offering band and choir during the school day. On a roll call vote, the following Board Members voted Aye: Diane Campbell, Trak Patel, Casandra Slade, Jane Gattone and Carissa LaTourette. Nays: none. Absent: Nichol Mangino. The motion passed.

<u>DRAMA COURSE</u> -- A motion was made by Diane Campbell and seconded by Trak Patel to approve offering a drama course. On a roll call vote, the following Board Members voted Aye: Trak Patel, Casandra Slade, Jane Gattone, Carissa LaTourette and Diane Campbell. Nays: none. Absent: Nichol Mangino. The motion passed.

<u>ADDITION OF ENRICHMENT CLASSES</u> -- A motion was made by Jane Gattone and seconded by Carissa LaTourette to approve the offering of enrichment classes during study hall period. SEMESTER CHOICE OPTION FOR 8TH GRADE SPECIALS -- A motion was made by Jane Gattone and seconded by Trak Patel to approve a semester choice option of science enrichment, art or technology for 8th grade specials. 1:1 IPAD PILOT EXTENSION -- A motion was made by Carissa LaTourette and seconded by Diane Campbell to approve extending the 1:1 iPad pilot initiative for two full grade levels (3rd and 6th) and two additional classrooms (5th and 8th), including a 0.5 FTE for tech integration. On a roll call vote, the following Board Members voted Aye: Carissa LaTourette, Diane Campbell, Trak Patel and Jane Gattone. Nays: Casandra Slade. Absent: Nichol Mangino. The motion passed.

ADDITION OF 0.5 FTE AIM TEACHER -- A motion was made by Diane Campbell and seconded by Carissa LaTourette to approve the addition of a 0.5 FTE AIM teacher. On a roll call vote, the following Board Members voted Aye: Diane Campbell, Trak Patel, Casandra Slade, Jane Gattone and Carissa LaTourette. Nays: none. Absent: Nichol Mangino. The motion passed.

ADDITION OF 1.0 FTE ADMINISTRATOR — Supt. Jason Lind explained that an adding an administrator would provide support in the areas of curriculum, special education, evaluations and discipline. A motion was made by Jane Gattone and seconded by Diane Campbell to approve the addition of a 1.0 FTE administrator. On a roll call vote, the following Board Members voted Aye: Trak Patel, Casandra Slade, Jane Gattone, Carissa LaTourette and Diane Campbell. Nays: none. Absent: Nichol Mangino. The motion passed.

ADDITION OF 1.0 FTE PARAPROFESSIONAL – A motion was made by Jane Gattone and seconded by Carissa LaTourette to approve the addition of a 1.0 FTE paraprofessional (supervision for study hall). On a roll call vote, the following Board Members voted Aye: Casandra Slade, Jane Gattone, Carissa LaTourette, Diane Campbell and Trak Patel. Nays: none. Absent: Nichol Mangino. The motion passed.

ACTIVITY FEES AND TRANSPORTATION COSTS — Supt. Jason Lind explained that the Activity Fees and Activity Bus Fees for next school will remain generally the same, except for the fee for band, which is being decreased. Students who choose to take band or choir only during the school day will not be charged a fee. A motion was made by Jane Gattone and seconded by Diane Campbell to approve Activity Fees and

Transportation Costs for the 2016-17 School Year. On a roll call vote, the following Board Members voted Aye: Jane Gattone, Carissa LaTourette, Diane Campbell, Trak Patel and Casandra Slade. Nays: none. Absent: Nichol Mangino. The motion passed.

BOARD VACANCY — Supt. Jason Lind discussed a proposed timetable for filling the vacancy on the School Board created by the resignation of Greg Ball. The applications will be reviewed at the Committee Meeting. The Board can then decide if they want to interview the applicants. The new Board Member could be appointed at the Regular Board Meeting in May. Board Members came to a general consensus to follow the proposed timetable.
