## First Reading of the FY16 Property Tax Levy

Dr. Johns explained that the levy uses the equalized assessed value (EAV) from the 2016 calendar year and generates tax revenue that is received in June and September 2017. This revenue is then used to fund the 2017-18 school year. There is no need for a public hearing as the requested increase is less than 5%. This levy and resolutions will be on the agenda in December for adoption.
