Bus Lease

The Board approved a four-year bus lease for sixteen 71-passenger buses, two 28-passenger buses, and two wheelchair buses. This new lease will cost \$2,200 less per year than we paid for the past three years. The bus company comes on site to service the buses. If brakes or tires need to be replaced during the term on the lease there will be no charge.

Mrs. Gattone also visited an eighth grade math class and the staff rooms during lunch break. She ate lunch in the cafeteria and said that the chicken quesadillas were very good. There was a lot of energy and a lot of activity going on.

Mr. Ball visited the Elementary School and read to four different classrooms. One class was talking about how open the room is, because last year there were two more desks squeezed in there. Kindergarten teachers were saying how the students are already at the reading level that half-day kindergarteners were at the end of the year. Mr. Ball said it was nice to see the energy, excitement, and happiness of the students.

Mrs. Mangino related that at the Vision 20/20 conference it was said that full day kindergarten gives you the "biggest bang for your buck" down the road in achievement scores.

Business Office Report

Dr. Johns reported that we have received 98.89% of property tax revenue. The district received approval for tax anticipation warrants from State Bank of the Lakes for \$500,000, which can be requested in \$100,000 increments. Standard & Poor's upgraded the district from A- negative to A- stable.
