### Business Office Update April 24, 2013, 2013 COW Meeting

# **Property Tax Levy**

- The "Levy Extension" worksheets were received on April16, 2013. Mr, Lind and I made the required adjustments and the sheets were returned to the County Clerk's Office.
- Next, I will be receiving the "Final Certification" that will be reviewed for accuracy before the rates are certified by the Treasurer's Office and the property tax billing process begins.
- The EAV of the district dropped by 9.19% from 2011 to 2012. I had estimated an 8% drop.
- The 2012 Levy adopted and the anticipated final levy amounts for the funds that are subject to PTELL are listed below.
- I had estimated a levy of \$9,160,629.77 assuming \$500,000 of new construction. Our new construction numbers came in at \$193,352. It looks like the actual levy will end up at \$9,148,956.51.

## Possible Need for a Budget Amendment

- In reviewing the status of the individual funds:
  - The Debt Service Fund will be approximately \$1500 over budget due to underestimating the copier leases and the annual fees we pay to the bank for paying the bond holders of the District's bonds.
  - The Operations and Maintenance Fund is running at 74% of budget as of March 31, 2013. This is very close to budget, but we have had some costly and unavoidable repairs over the last few months. It is possible that we may end the year under budget, but I can't make any promises. The budget will be very close.
- I did speak to the auditor, David Cain, regarding the need for a budget amendment. Mr. Cain told me that a budget amendment was not necessary, but there would be a note in the audit. He doesn't recommend that the district go through the amendment process due to the work needed to prepare, advertise, and hold the public hearing and file the amended budget with the state and the County Clerk. Variances from each fund budget are allowed up to 10% over the adopted budget.
- In summary, the total combined budget will end the year under the budget adopted by the Board in September, 2012. However, two individual funds have the potential to be slightly over budget.
- I need direction from the board since the amended budget would need to be approved for public display at the first meeting in May and adopted at the regular board meeting in June to comply with the notice requirements.

### **Food Service**

- The food service bid process that we went through last summer allows the district to renew the current contract with Arbor Management as long as the increase doesn't exceed the CPI increase for "Food Away from Home" (2.5%).
- I am recommending that the board approve the extension of the Arbor Management Contract for the 2013-14 school year. The contract reflects a 2.5% increase over the current contract.

## **Summer Help Hiring Process**

- 1. Temporarily increase hours of current part-time custodial staff (total of 5 hours daily)
- 2. Advertise for summer help on the District Website
- **3.** Review and select applicants with Millburn District 24 experience for interviews. Recommendations will be based on their interview and prior work record with the district.
- 4. For any additional open positions, applicants would be selected from the remaining applicant pool and interviews would be scheduled.
