Business Office Update April 11, 2016 Meeting

Summer Projects Update

- The pre-construction meeting for the "Electrical/LED Lighting" project was held on April 5, 2016. Work will begin on June 8, 2016. There is a possibility that work on the exterior wall-pack lights may start earlier than June 8, 2016.
- The pre-construction meeting for the paving and drainage work has not yet been scheduled.
- The process of compiling the summer projects list has started. The items that weren't completed last summer started the list and then additional items have been added. A list of the items completed in 2015 and the projects that have been suggested for 2016 is attached.

Funding for the DCEO Energy Rebates

- The pre-construction paperwork for the DCEO energy rebates has been completed and Millburn will be eligible for almost \$60,000 in energy rebates. However, the DCEO funds are currently a part of the funds that have been frozen since there is no budget appropriation authorizing spending of the funds. If funds aren't spent by May 31, 2016, the charges for this program that comes from the electric bills of every electric customer in Illinois will be reduced next year to almost \$0. By submitting our project request in this budget year, there is a chance that we will be able to re-submit when the funds are unfrozen and receive our rebates.
- Unfortunately, projects that districts may want to do next year may have no electric rebates available if money isn't released and spent by May 31, 2016. SB2803 is making its way through the legislative process with a goal of releasing the funds.
 - O SB2803 would give utilities the ability, under the direction of the Department, to pay program participants and grant administrators directly for their energy efficiency projects and services. Allowing utilities, with the Department's instruction, to pay participants and vendors directly would prevent continued harm to the program from a lack of appropriation.
 - O There is some hope by the way of a bill that is currently in the legislature. On Wednesday, April 6th, the Illinois Senate Government and Veterans Affairs Committee held a hearing on SB2803, a bill to fund the state's Public and Low-Income Energy Efficiency Program. The bill passed committee onto second reading with an agreement some changes will be made before bringing the legislation to the floor.
 - The major concern is that if the bill passes the house and senate, the Governor has stated that he
 will not sign any bills that authorize funding if they aren't comprehensive and include his reform
 package.

Millburn Middle School Roof

• The roof at the middle school will be repaired the last week in April after the PARCC testing is completed.

Cottonwood Subdivision Private Agreement

- At the next meeting, I will be recommending that the board approve three private agreements with developers of the Cottonwood subdivision. The district entered into a private agreement with the developer in October, 2003 to charge impact fees. Since that time, the property has been subdivided and there are now three developers. The agreement will also have an updated impact fee schedule based on the formula in the original agreement.
- The board will also need to authorize a letter to the Lake County Regional Superintendent of Schools that the district will be entering into an agreement with the developers.
- And finally, the board will need to approve an indemnification agreement that will allow Lake County to collect the impact fees on the behalf of Millburn School District 24.

Property Tax Levy

- I received the preliminary property tax levy last week. I made some changes in the preliminary report and we have now received our final levy numbers after the assessed value was certified.
- The total levy is \$277 more than I anticipated when the board approved the levy in November, 2015.
- A chart showing the estimated levies and actual levies is attached.

Health, Dental, & Vision Insurance

- Rates
 - There was no increase in rates for the PPO Health Insurance, dental and vision insurance for the district
 - o The HMO plan will increase by 3.8% effective June 1, 2016.
- Open enrollment will run from April 20, 2016 through May, 11, 2016.
 - o Amy Abell and Catherine Loney from GCG, our broker, will be available in both buildings on the morning of April 27, 2016.
- Insurance Committee
 - The insurance committee met on March 31, 2016 with Catherine Loney. The majority of the meeting was a review of our current benefits and discussion about a high deductible plan that the district could consider offering in June, 2017.
