This list is meant to provide a guideline when purchasing snacks. Allergen safe lists quickly become outdated as product lines change, and currently there is no legislation to ensure that manufacturers place factual labeling statements about a product's manufacturing environment.

Avoid products whose labels read:

- Manufactured/processed in a facility that contains peanuts / nuts
- may contain traces of peanuts / nuts
- made on shared equipment

We ask that you carefully check the ingredient label on the package each time.

- Generic brands of/= name brand foods on the safe snack list
- Hershey's assorted miniature candy bars
- Hostess products
- Jelly Belly brand jellybeans
- Keebler cookies
- Little Debbie products
- M&M Candy (ALL)
- M&Ms- plain or peanut
- Oreo Double Delight Chocolate, Peanut Butter Cookies, and Cakester
- Peanut butter/nuts/trail mix
- Ritz-bitz sandwich crackers
- Slice & Bake (Ready Made) Cookie Dough
- Snyder's Pretzels
- Stauffer's Brand Items (animal crackers, baked goods, etc)
- Toll House chocolate morsels, chocolate chunks, swirled chips

NOT safe / possible cross-contamination

- Do not send any snacks or candy that contains peanut flour, peanut oil, or other nuts. This
 includes snacks with pecans, almonds, Brazil nuts, filberts, cashews, hazelnuts, macadamia nut,
 pine nuts, pistachios, and walnuts
- Mixed bags of candy may contain safe and unsafe candy and are subject to cross-contamination.
- Do not send items from bulk bins
- Do not use the same knife, spatula, cutting board used to make unsafe foods to cut fruit or veggies
- Most popcorn products contain traces of nuts or nut oils
- No hydrolyzed vegetable protein, arachis, mandelonas, or emulsifiers

In addition, products without ingredient lists are unsafe
