## CERTIFICATE of LIABILITY

A Certificate of Liability Insurance with Millburn School District 24 listed as an additional insured in the following amounts is needed:

- General liability- \$1,000,000 per occurrence /\$3,000,000 general aggregate.
- Auto liability: \$1,000,000 per occurrence.

All non-school related groups must supply adequate supervision to ensure proper care and use of school facilities. The non-school related group is responsible to the Board for the use and care of the school facility. All adult supervisors must have cell phones with them at all times. Sufficient, competent adult supervision must be provided and the adult supervisor must ensure that no minor is left alone after the activity. Only assigned classrooms, the cafeteria, auditorium, gymnasium, and assigned athletic fields, along with needed hallways and parking areas, are available for community use. Entering any room or area not in use by the group is prohibited. The adult supervisor will vacate the facility at the scheduled end time. Use of the school facility is not permitted past the agreed end time. No tables, bleachers, furniture or equipment may be moved without prior approval from the Building Principal. Signs, displays, or materials may not be attached, nailed, or otherwise Initial here if this is agreeable affixed to walls. All non-school related groups must agree to: · Indemnify and hold harmless the District and its agents and employees for and from any and all loss including attorneys' fees, damages, expense, and liability arising out of its use of school property. · Pay any damages to school facilities, furniture, or equipment arising out of its use of school property whether such damage was accidental or deliberate. The cost of damages will be based on the repair or replacement cost, the choice of which is at the School Board's discretion. · Supply proof of insurance naming MILLBURN SCHOOL DISTRICT 24 as an additional insured and verifying that the group maintains adequate insurance coverage against personal injury and/or property loss: Insurance provider name and contact number If the request involves a physical fitness facility, the non-school related group must: Designate at least one adult supervisor who agrees to be an emergency responder. All emergency responders are encouraged to be trained in CPR and AED use. • Be given a copy of the District's plan for responding to medical emergencies to each designated emergency responder. • Require that 9-1-1 be called for medical emergencies and whenever an AED is used. • Ensure that each designated emergency responder knows the location of first aid equipment and any AED. • Ensure that only trained AED users operate an AED, unless the circumstances do not allow time for a trained AED user to arrive. • Arrange for at least one emergency responder to have a tour of the facility before the activity. • Ensure that if an AED is used, the Superintendent is informed and all appropriate forms are completed.
