

RESOLUTION

DISMISSAL OF FOURTH-YEAR PROBATIONARY TEACHERS FOR FINANCIAL REASONS

WHEREAS, the Board of Education has decided to decrease the number of teachers in the School District; and

WHEREAS, the following teachers are completing their fourth consecutive full term of probationary teaching service during the 2010-11 school term; and

WHEREAS, the Board has determined that said teacher(s) shall be dismissed at the end of the 2010-11 school term, pursuant to Section 24-11 of the *School Code* (105 ILCS 5/24-11), as a result of the Board decision;

NOW, THEREFORE, Be It Resolved by the Board of Education of Millburn Community Consolidated School District No. 24, Lake County, Illinois, that:

Section 1: The following named fourth-year probationary teacher(s) shall be dismissed at the end of the 2010-11 school term because of the decision of the Board to decrease the number of teachers employed due to a lack of funding:
