II. The corporate and special purpose property taxes extended or abated for 2010 were \$8,716,525.

The proposed corporate and special purpose property taxes to be levied for 2011 are \$9,588,178. This represents a 10.00% increase over the previous year.

III. The property taxes extended for debt service and public building commission leases for 2010 were \$1,940,778.

The estimated property taxes to be levied for debt service and public building commission leases for 2011 are \$2,073,428. This represents a 6.83% increase over the previous year.

IV. The total property taxes extended or abated for 2010 were \$10,657,303

The estimated total property taxes to be levied for 2011 are 11,661,606. This represents a 9.42% increase over the previous year.
