II. The corporate and special purpose property taxes extended or abated for 2014 were \$10,319,682.84.

The proposed corporate and special purpose property taxes to be levied for 2014 are \$10,978,088. This represents a 6.38% increase over the previous year.

III. The property taxes extended for debt service and public building commission leases for 2013 were \$2,363,643.11.

The estimated property taxes to be levied for debt service and public building commission leases for 2014 are \$2,650,000. This represents a 12.12% increase over the previous year.

IV. The total property taxes extended or abated for 2013 were \$12,683,325.95.

The estimated total property taxes to be levied for 2014 are \$13,628,088. This represents a 7.45% increase over the previous year.
