A Committee of the Whole Meeting of the Board of Education of Millburn School District 24, Lake County, Illinois, held at Millburn Middle School, was called to order at 7:32 p.m. by President Joseph Pineau. ADDITIONAL INFORMATION/DISCUSSION ITEMS - There were none.

RECOGNITION – Supt. Jason Lind recognized Jennifer Penzenik, a SEDOL teacher at Millburn, and Anne-Marie Maier, a fifth grade teacher. The teachers, for a second year, collaborate to bring their students together in an activity they call Peer Buddies. For 30 minutes each week Ms. Maier's 5th graders and Ms. Penzenik's special education students work together on a variety of activities involving crafts, academics or holiday celebrations. Ms. Penzenik presented a slide show highlighting the program and students. One of the most popular events was the "Sedolympics," in which a gym was transformed into an Olympic-type setting with physical activities and medal presentations.

INFORMATION/DISCUSSION ITEMS

<u>TAX BILLS</u> – Supt. Jason Lind said he has been hearing from several taxpayers since the tax bills were received. Community members with questions and comments can be directed to Supt. Lind or Dr. Stephen Johns. They are available to discuss the property tax system and answer questions regarding tax bills.

<u>DISTRICT DASHBOARD</u> – Supt. Jason Lind reviewed previous Board discussions about adding a Dashboard to the district website. He distributed a handout with an example of the Dashboard used by a nearby district. The handout also showed how Illinois Report Card data is currently displayed on the Millburn website. The Board discussed including more financial information, and more information that compares Millburn's spending, funding and academic achievement to area districts. Supt. Lind said he will continue to work with the Board to present pertinent district data in an easily accessible format.
