Dear Steve:

We recommend the following be presented to the Board of Education.

On Monday, March 11, 2019, at 2:00 pm bids were received from six (6) contractors for the Millburn 2019 Summer Upgrades. A bid tabulation is attached for your review. Rasch Construction from Kenosha, Wisconsin submitted the low base bid in the amount of \$429,500.00.

Rasch Construction has informed us that they discovered an error in their bid and have requested the Board allow them to withdraw their bid and have their bid bond returned per their attached letter. We believe it is in the best interest of the Board to allow them to pull their bid from consideration for award.

The next low bidder is Camosy Construction of Zion, Illinois with a base bid amount of \$469,900.00 and the acceptance of unit prices as follows. Note the selection of unit prices does not affect the low bidder or the total contract price.

Unit Price No. 1 Removal/Replacement of existing plywood sheathing at garage reroof/residing Add (\$235/4'x8' sheet of plywood)

This unit price is to add or deduct from the Contract Sum to remove uncovered areas of damaged plywood sheathing at the roof or wall locations and install new plywood beyond the extents shown on the Drawings.

Recommendation: Accept this Alternate

Unit Price No. 2 Removal/Replacement of metal stud framing at Middle School soffits Add (\$160/LF of framing)

This unit price is to remove uncovered areas of damaged metal stud framing at the Middle School soffit locations and install new metal stud soffit framing beyond the extents shown on the Drawings.

Recommendation: Reject this Alternate

Our recommendation for award is as follows:



Allow Rasch Construction to remove their bid from consideration and return their bid bond. Award the contract to Camosy Construction for the base bid amount of \$469,900.00 along with Unit Price No.1.
