Dear Superintendent:

A statement is enclosed containing information about your district's Fiscal Year 2019-2020 membership in the Illinois Association of School Boards. We thank you for your continued support.

Dues are calculated based upon three variables: Base Charge + (Weighted Factor x Operating Expense). The Base Charge and the Weighted Factor are currently linked to average daily attendance (ADA). Your dues statement includes the following:

- ADA for 2015-2016
- Net Operating Expense for 2016-2017
- Calculated dues (what your dues would be under the formula if IASB did not cap the actual increase)
- Restricted Annual Dues (the amount of IASB dues the district is actually paying)

Any increase in dues is linked to an increase in ADA beyond a district's current tier or in the operating expenses of the district. IASB limits the dues increase by applying an annual cap.

As part of the Association's Strategic Plan approved by the Board of Directors in August 2018, IASB staff completed an analysis of the current dues formula and the distribution of member dues. The next step in this review process is to examine potential modifications to the dues formula. The strategic plan also includes the introduction of new training opportunities and enhanced services for our membership. Look for a fall launch of a new IASB website. You will also see new and "refreshed" IASB workshops. We intend to follow-up a successful launch of "super division" Collective Bargaining workshops in February, with the roll out of a new *Leading and Monitoring for Equity* workshop that will be available in the fall.

As the number of PRESS Plus subscribers to policy services continues to grow, we will continue to focus on building our capacity to respond in a timely manner to the needs of the membership.



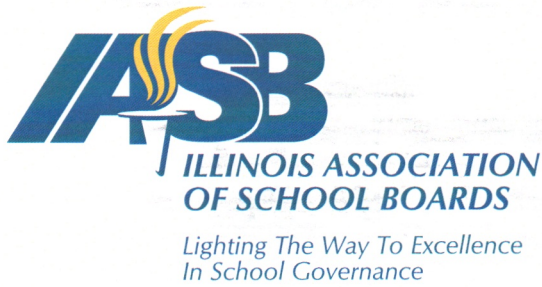

Excellence in local school board governance

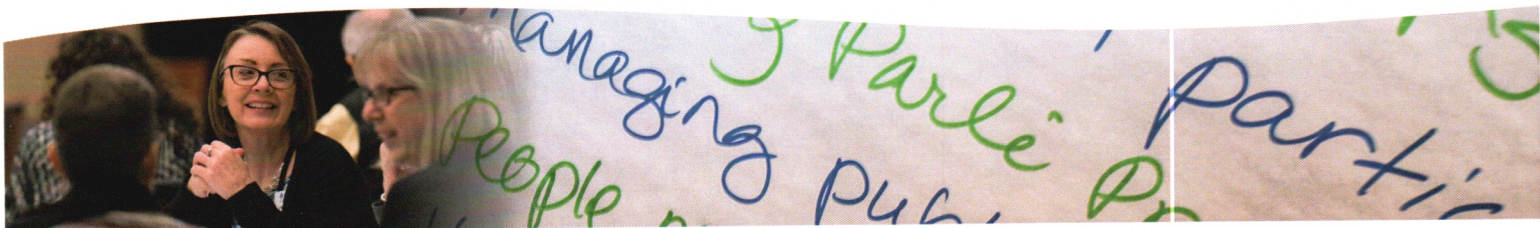
